### **5. Can I bring my ESA into restaurants or grocery stores in Florida?**

No. Emotional Support Animals are not Service Animals under the ADA. They do not have public access rights to go into places where pets are generally prohibited, such as restaurants, malls, or grocery stores. Their primary legal protection applies to housing under the Fair Housing Act.

### **6. How quickly can I get my letter from RealESALetter.com?**
